

PRIVACY POLICY

the company under Dutch law Africa Unsigned BV i.o. registered in The Netherlands under Chamber of Commerce number 32159953, with a branch office at De Ruyterkade 127, 1011 AB Amsterdam, The Netherlands (hereinafter to be referred to as “Africa Unsigned”) and its subsidiaries respect the private sphere of Artists, Users, and interested parties (hereinafter called “Users”) who visit the website at the Internet address www.africaunsigned.com. Africa Unsigned therefore agrees to respect your private sphere and the confidentiality of your personal data and data transfers in compliance with the provisions of data protection laws.

The purpose of this policy is to help you understand how Africa Unsigned uses and protects your personal data.

Personal data are information that identify you and that can be used online or offline in order to reach you.

We collect, store and process personal data during registration and/or customer support or technical service enquiries, on the marketing surface and during e-mail campaigns.

Africa Unsigned also collects other than personal identifiable information, the IP address, profile information, overall user data, and the browser type of users of this website. This information is used for maintaining the website and identifying any trace uses, for improving the website services, and for security and monitoring purposes.

Stored personal information can – depending on its use – contain your name, your e-mail address, your phone and mobile phone numbers, your home address, your sex, your birth date and credit card or bank account information.

We collect and pass on only information that is necessary for exercising rights and meeting obligations resulting from the terms and conditions of use, the Agreements on Artists’ participation in the Africa Unsigned program, Agreements with the Supporter and for reaching our legitimate business goals.

Users under the age of 18 must not pass on any personal information without the explicit prior agreement of their legal representative. For registration purposes the corresponding form for granting the agreement will be made available. This form must be signed by the legal representative of the users and be returned to Africa Unsigned by e-mail.

We use cookies and other techniques for passively collecting demographic information, personalizing your use of our site, and for monitoring adverts and other activities. Cookies are small files stored on your computer for monitoring movements within the website. We also use cookies for storing details of the content in your interest. We can combine cookies information with personal information.

Adverts that appear on this website can be supplied to Users of Africa Unsigned or to our network advertising partners. Our advertising partners can create cookies. These cookies make it possible that the advertiser’s server recognizes your computer any time when you send an online advertisement. In this way the servers can gather information on the adverts visited. As a result an advertisers’ network can send adverts of which you believe that they may be useful to you.

This privacy policy contains the use of cookies by Africa Unsigned and each advertiser.

Most browsers are set such that you have to accept cookies any time you visit a website.

You can block cookies or set your browser such that it warns you any time when cookies are being sent.
